CRM retains all rights in and to all intellectual property related to the Training and the Materials including, but not limited to, any copyrights in the Materials and all associated trademarks. Your participation in the Training does not result in the sale, license, or transfer of any title, ownership right, or interest in or to any of the Materials.

In the event that CRM or any member of its staff or faculty requests that I discontinue my participation and involvement with the Training, I agree that I will immediately stop my participation in the Training and will leave the Training location. If I withdraw from the Training,

I will at all times be a fully paid and up-to-date member of a professional association maintaining an industry-standard code of ethics, AND/OR I will at all times maintain a fully paid and up-to-date professional license with an applicable regulatory agency. I will provide proof of active membership and/or professional license to CRM upon renewal.

I certify that no grievance, complaint, or action has been brought or filed against me before any licensing, regulating, associative, or legal body for any violation or misconduct of any kind.

By Submitting This Agreement, I certify that all the information included in this agreement is true and complete. I agree to appear and act in a professional manner at all times while participating at Trainings and/or interacting with CRM training students, trainers, assistants, and coordinators, both within and outside the training environment. I acknowledge that CRM reserves the right to approve or deny any request to take the Training, can revoke approval at any time, and approve or deny the participation of any person, in its sole discretion, with or without cause, and in accordance with its policies and the law.

This Agreement is the only agreement between me and CRM regarding my participation in the Training, supersedes any other similar agreement, and cannot be modified except in writing by CRM. This Agreement will be binding upon me and my heirs, executors, administrators, and legal representatives.
